X. Shiloh Farm Landing Project Presentation:

The Shiloh Landing site is situated in Edgecombe County between Tarboro and Princeville. Steeped in history, this site offers a popular destination for visitors and local residents alike. While the site is currently minimally developed, this plan illustrates some ideas that could assist in attracting visitors to Shiloh Landing and the surrounding areas. The further expansion of this site as a tourism destination will impact the surrounding towns in several ways, such as increased traffic and visitor discretionary spending. The ideas within the plan seek to highlight the historical events that took place at Shiloh Landing and nearby areas while simultaneously employing the natural amenities offered. In addition, the future of this site, and how it will distinguish itself from other similar destinations in the region, will be described with the goal of offering a truly unique experience that attracts outside visitors and makes local residents proud.
